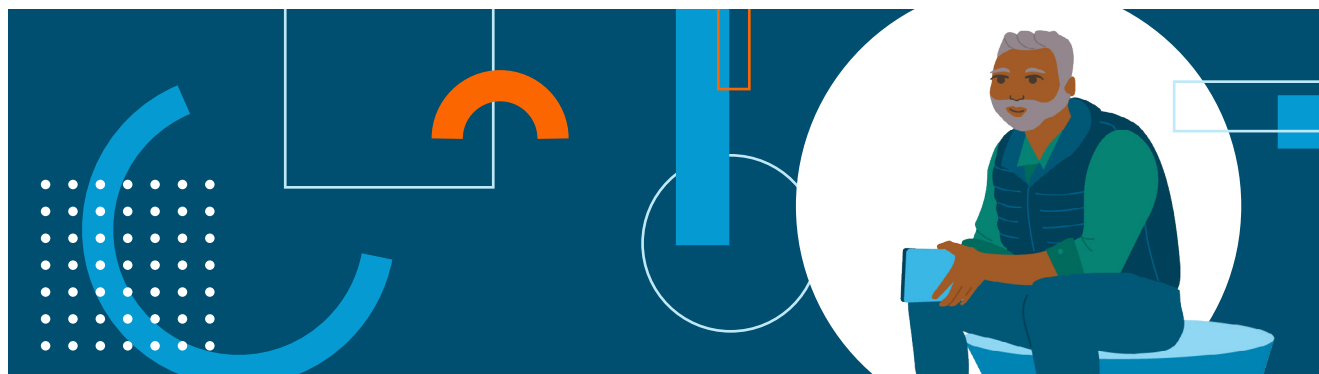

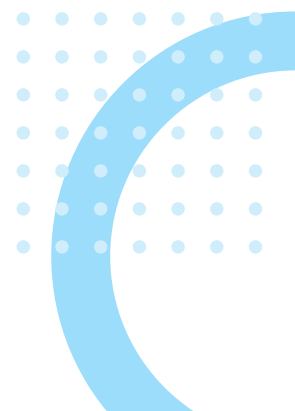

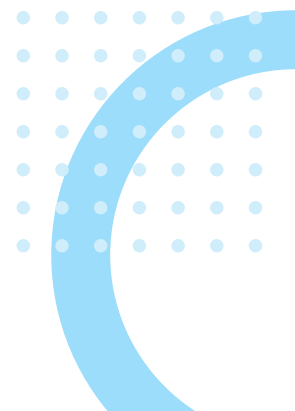

The user can then correct the error and resubmit the invoice for e-invoicing.

Real ROI that benefits the bottom line

Avalara commissioned Forrester Consulting to conduct a [Total Economic Impact™ \(TEI\) study](#) on the return on investment (ROI) companies might expect by automating tax compliance with Avalara. Forrester interviewed six Avalara customers about the ROI they realized from Avalara solutions and constructed a composite global company that uses AvaTax, Exemption Certificate Management, Managed Returns, and Tax Research, and aggregated financial analysis from the responses.

Prior to automating tax compliance with Avalara, interviewees said they experienced difficulty collecting and remitting tax in all jurisdictions where they have nexus due to frequent tax law changes. Study participants also said their businesses faced challenges managing exempt sales and higher audit risk due to incorrect or missing forms when filing returns.

After implementing Avalara, TEI study participants said they were able to more accurately calculate taxes, reduce time and errors filing tax returns, efficiently manage exemption certificates, and prepare for audits, which effectively lowered their organizations' potential liabilities for noncompliance.

The results showed that on average, Avalara solutions helped the composite organization save:

- 34 hours per audit, gaining 85% efficiency by reducing time spent on audits
- 510 hours annually on managing and filing tax returns, saving more than \$83,000 over three years
- \$150,000 annually by eliminating the need to hire third-party tax consultants
- 384 hours annually by cutting time spent researching changes to tax rates, rules, and obligations

Overall, the composite organization experienced a **153% return on investment** within a payback period of less than six months.
